# STADIUM GENERAL PROVISIONS

## 1. GENERAL PROVISIONS

- 1.1. These rules apply to all stadium visitors.
- 12. By entering the stadium, spectators agree to abide by these regulations.
- 1.3. These rules are intended to ensure the safety of spectators, players, and staff.

## 2. PROHIBITED ITEMS

The following items are strictly prohibited within the stadium premises:

- Weapons, firearms, explosives, flares, smoke bombs, fireworks, or pyrotechnics of any kind.
- Glass containers, cans, alcoholic beverages, or any illicit substances.
- Large bags, backpacks, hard cases, and umbrellas.
- Racist, xenophobic, political, offensive, or inflammatory banners, flags, signs, or clothing.
- Laser pointers, horns, loudspeakers, megaphones, or other noisemaking devices (unless pre-approved).
- Drones, professional cameras, tripods, or recording equipment (unless accredited media).

Stadium management reserves the right to confiscate any prohibited items.

#### 3. PROHIBITED BEHAVIOURS

The following actions are strictly forbidden:

- Entering the field of play, technical areas, team zones, or other restricted sections.
- Engaging in violent, aggressive, provocative, or discriminatory behavior.
- Throwing objects, liquids, or projectiles.
- Lighting fires, flares, or smoke devices.
- Climbing on barriers, fences, roofs, or stadium structures.
- Using abusive, insulting, or threatening language or gestures.
- Displaying unauthorised political, ideological, or religious messages.
- Engaging in unauthorised commercial or promotional activities within the stadium. Violators may be removed, banned, or subject to legal action.

## 4. FLAGS, BANNERS AND VISUAL MATERIALS

- 4.1. Flags and banners may be brought into the stadium only with prior approval.
- 4.2. All materials must be flame-retardant and free from offensive or discriminatory content.
- 4.3. They must not obstruct the view of other spectators, signage, or advertising boards.

#### 5. FILMING AND BROADCASTING

- 5.1. Personal photography and short video recording are allowed for private use only.
- 5.2. Match broadcasting or professional filming without accreditation is prohibited.
- 5.3. Use of drones inside or above the stadium is strictly prohibited.

### 6. SEATING AND CONDUCT

- 6.1. Spectators must occupy only the seat assigned to them as per their ticket.
- 6.2. Aisles, stairways, emergency exits, and pathways must be kept clear at all times.
- 6.3. Standing is permitted only in designated standing areas.
- 6.4. Spectators must always follow the instructions of security, staff, and police.

#### 7. CHILDREN AND ACCESSIBILITY

- 7.1. Children under 14 must be accompanied by an adult.
- 7.2. Special services, seating, and assistance are available for persons with disabilities.
- 7.3. Spectators are encouraged to notify the organizers in advance of any special needs.

## 8. HEALTH AND SAFETY

- 8.1. If you feel unwell or see someone injured, notify staff immediately.
- 8.2. Spectators are encouraged to use hand sanitizers and follow hygiene protocols.

#### 9. EVACUATION AND EMERGENCIES

- 9.1. In case of evacuation, spectators must follow the instructions of stadium staff and authorities.
- 9.2. Emergency exits and evacuation routes must remain unobstructed at all times.
- 9.3. Avoid panic remain calm and proceed in an orderly manner.

#### 10. LIABILITY AND SANCTIONS

- 10.1. Violators may be ejected, fined, or prosecuted according to applicable laws.
- 10.2. Tickets may be confiscated without refund.
- 10.3. Organizers are not responsible for lost or stolen personal belongings.

#### 11. FILMING

- 11.1. By entering the stadium, individuals acknowledge that they are in a public space.
- 11.2. The stadium may be monitored by surveillance cameras for security purposes.
- 11.3. Visitors consent to being filmed and photographed.
- 11.4. Recorded footage may be used by law enforcement or event organizers when necessary.
- 11.5. Personal data is processed in accordance with applicable data protection laws.

#### 12. ENTRANCE TO STADIUM

- 12.1. Access to the stadium is permitted only with a valid ticket or accreditation.
- 12.2. All spectators must undergo a security check at the entrance.
- 12.3. You may be required to present a valid ID at the entrance.
- 12.4. Persons who are intoxicated or under the influence of drugs will be denied entry.
- 12.5. Organizers reserve the right to deny entry to any individual on safety grounds.
- 12.6. Entry with someone else's or a counterfeit ticket is strictly prohibited.
